9. Request to approve contracting of water line extension and bore under East 180

Houston Satterwhite, Public Works Director, explained the waterline issues with water pressure involving multiple households. We have received bids and believe Fambro was the lowest and our recommendation is to go with Fambro.

Commissioner Blue made a motion seconded by Mayor Pro-Tem Cyprian, to approve contracting of water line extension and bore under East 180. When the motion was put to vote, it prevailed as follows: Ayes: Sims, Cyprian and Blue Nays: None. Absent: Wimberley and Durham

10. Request to approve contracting of asphalt to repair potholes

Andy McCuiston, City Manager explained the staffing and weather issues that have impacted the streets. We would like to use \$50,000 of the Street Maintenance Fund to contract out to fix streets that are the worse. If we go above \$50,000 per project we would have to go out for formal bid. Pot holes will not have a warranty like a new street would. Due to weather conditions we need something done quickly. We have received quotes of \$3.50 per square ft.

Mayor Pro-Tem Cyprian made a motion seconded by Commissioner Blue, to approve contracting of asphalt to repair potholes. When the motion was put to vote, it prevailed as follows: Ayes: Cyprian, Blue and Sims Nays: None. Absent: Wimberley and Durham

11. Request to bid the Highway 183 North waterline

Andy McCuiston, City Manager stated we are ready to go out for bids and plan to award in February.

a. Report on purchase of ladder truck

Fire Chief Chaney stated he went to Florida and looked at the truck, this is something we were in need of. Cost was \$75,000, we sold a pumper truck for \$65,000 so we are only out \$10,000 and \$3900 to transport it from Florida. This ladder truck only has 20,000 miles and was well cared for. This will also improve our ISO rating.

Mayor Pro-Tem Cyprian made a motion, seconded by Commissioner Blue, to adjourn the meeting.


