5. Consider an amendment to the zoning ordinance to allow home-based child day care and home schooling as permissible home occupations in all residential districts in the City of Breckenridge, Texas.

Mike Griffith opened Public Hearing at 5:35 P.M.

Will Holt, Kathy O'Shields, Jenny Holt, William Smith, Rhonda Reeves, Dan Young, and Gary Trammell all spoke about their reasons for opposing the home-based child day care issue. Eileen Hayman, City Attorney explained existing long-term operating home-based day cares as non-conforming placed under a Grandfather Clause. Goad asked about babysitting Grandchildren, City Attorney explained the difference is this is an occupation. Calvin Chaney, Fire Chief reviewed existing list of the licensed long-term operating daycares: Darlene Hill – 1201 N Liveoak (outside City limits), Jr. Buckaroo Academy – 110 N Graham (I-1), Durana Herring – 1002 N Liveoak (R-1), Phallon Mendez (R-1). There are only two (2) that would fall under the Grandfather Clause and they are: Durana Herring – 1002 N Liveoak (R-1) – in operation same address since 1987, Phallon Mendez (R-1) – in operation same address since 2010.


